## Section 3

**MODE OF PAYMENT**

1. For admission to Diploma courses 2024-25, the application form will be available only on the university website **www.luvas.edu.in**. The candidates seeking admission will apply **online only** and Application/Entance Test fees will be paid online at the time of submission of Application Form.

**Mode of payment: Online**

2. For **VLDD** Course, the candidates admitted provisionally at **IPVS, LUVAS, Hisar** and in the **Affiliated Private Institutes/Colleges**, annual fee is to be deposited by all the candidates at the time of document checking at the fees counter of COVS, LUVAS, Hisar in the form of single Demand Draft drawn in favour of “**Director, IPVS, LUVAS, Hisar**” payable at **Hisar** (For details please see Chapter-V).

For **DVLT** Course, the candidates admitted provisionally at **IPVS, LUVAS, Hisar**, annual fee is to be deposited by all the candidates at the time of document checking at the fees counter of COVS, LUVAS, Hisar as a single Demand Draft drawn in favour of “**Director, IPVS, LUVAS, Hisar**” payable at **Hisar** (For details please see Chapter-V).

**Mode of payment: Demand Draft only**

**Note: Payment via NEFT/RTGS is not acceptable.**



## Section 4

**IMPORTANT INSTRUCTIONS**

1. The application form will be available only on the admission portal of the University website ([www.luvas.edu.in](http://www.luvas.edu.in)). The candidates seeking admission have to apply **online only**.
2. Read the prospectus carefully before filling up the application form. Parivar Pehchan Patra (PPP ID i.e. Family ID) of the candidate of Haryana Residence is mandatory before applying for admission in the University. The basic details of the candidate i.e. name, father's name, category etc. in the application form will automatically be fetched from the PPP ID. In case, the details fetched from PPP ID are edited by the candidate, then the candidate is required to get his/her PPP ID updated with correct details. The candidate has to submit the updated PPP ID at the earliest in the office of IPVS, LUVAS.
3. The duly completed application form should be submitted online on or before the last date along with required documents (see list in Annexure XVIII).
4. **The candidate has to fill preferences of Colleges/Institutes at the time of filling of application form and the preferences once submitted will be applicable for all online counsellings. The candidate can fill as many as preferences.**
5. All entries, especially **category** for reservation benefits etc., should be properly filled in. **Once the application form is submitted, any change in category will not be permissible.**
6. Online application form should be registered by the candidate with his/her mobile (OTP). Therefore, candidate will use his/her own mobile number only.
7. **BCA/BCB candidates must upload latest Income Certificate issued on or after 01-04-2024 along with category certificate. The children of person(s) having gross annual income of upto 8 lakh rupees shall get the benefit of reservation in admission.** The sections of the Backward Classes earnings above 8 lakh rupees per annum shall be considered as creamy layer. Similarly, EWS category candidate must upload latest **Income and Asset Certificate** issued on or after 01-04-2024. SC/DSC candidates must upload category certificate (See annexure III, XIX). Similarly, the Persons with Disabilities (PwD) candidate must upload the certificate issued by Civil Surgeon. All the certificates are to be produced at the time of counselling/document checking otherwise their candidature for admission will not be considered in the respective category and they will be debarred for subsequent online counsellings. However, such candidates may participate in mop-up counselling by paying difference of application form fee, if any.
8. At the time of document checking, the candidates must bring all the original documents (coloured Photocopy of documents will not be accepted), two sets of self-attested photocopies of original documents and two 2.0"x 2.0" size coloured photographs (**taken on or after 01-05-2024**) as uploaded on the application form.
9. Non-production of original and the self-attested photocopies of the documents at the time of document checking on his/her turn may make a candidate ineligible for admission.
10. **Attendance of the candidates** in person at the time of **document checking,**





**medical examination** and deposition of **Annual fees** as per fees structure fixed by Government of Haryana and “University registration fee and Administrative charges-cum-one year examination fees” on due date, are compulsory, otherwise their candidature will not be considered for the admission.

11. **Ragging** is banned with zero tolerance in the University. The University follows the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 as well as the directions given by the Hon'ble Supreme Court in this regard. If any incident of ragging comes to the notice of the University Authority, strict action will be taken as per rules and regulations as mentioned in Annexure-XVI. Affidavits in this regard have to be submitted by the admitted candidates and their parents/guardians on the day of registration. (See Annexure-XI & XII).
12. The University has imposed a ban on the use of motorized vehicles in the hostels, for which the admitted candidates shall have to submit an undertaking (See Annexure- XV).
13. Management quota seats are available only at the Affiliated Private Institutes/ Colleges.
14. Other state candidates can apply only for management quota seats. The Haryana resident candidates will be considered first for admission and the other state candidates will be considered thereafter for admission to management quota seats based on the marks obtained in VLDDDET-2024.
15. **Date of declaration of result** of VLDDDET-2024 shall be displayed on the LUVAS website: [www.luvass.edu.in](http://www.luvass.edu.in)
16. SSB Candidates can apply online or offline and report for document checking at the time of admission/counselling and pay “Application Processing fees and other charges” in total there and then.
17. All the in-service applicants including those from SSB have to submit photocopy of the filled online application form alongwith the required documents through proper channel to the Director, IPVS, LUVAS, Hisar latest by 7 days prior to 1st counselling otherwise their candidature will not be considered for admission.
18. **Last date for submission of photocopy of online application** and other documents through proper channel by Sashastra Seema Bal (SSB) and all other in-service applicants: **7 days prior to date of 1<sup>st</sup> counselling.**
19. **Counselling and other details:** The schedule of Online/Offline and Mop-up counselling(s) and other details pertaining to admission shall be displayed on university website [www.luvass.edu.in](http://www.luvass.edu.in). After declaration of VLDDDET-2024 result on website of the university, Director, IPVS will issue the counselling schedule. All admissions (state and management quota seats) will be done by IPVS, LUVAS, Hisar.

The candidate, who has been allotted seat as per the merit list in the respective category, has to report for document checking and other admission formalities in the Auditorium of College of Veterinary Sciences, LUVAS, Hisar as per the schedule to be uploaded on the university website, failing which he/she will have no claim for admission in subsequent online counsellings even if he/she is higher in merit. However, such candidates may participate in mop-up counselling, if any. If a candidate is allotted seat in any online counselling and he/she doesn't want upgradation then he/she has to give in writing at the time of document checking. If the college of admitted candidate is upgraded in the next counselling as per



his/her preference, then he/she has to report for that counselling in-person at LUVAS, Hisar for confirmation of his/her upgradation. If such upgraded candidate doesn't report in-person then he/she will lose his/her right of admission and he/she will be considered only in mop-up counselling.

20. As per State Govt. letter no. 5084(CFMS)-AH-4-2024/5319 dated-13.09.2024 of Additional Chief Secretary to Govt. Haryana, Animal Husbandry and Dairying Department, if any seat remains vacant even after the 2<sup>nd</sup> counselling for filling up seats for admission to VLDD programme in the affiliated private colleges, then the vacant seats shall be filled up by the concerned affiliated private college through the Merit list of VLDDDET -2024 examination. The college shall widely publicise the vacant seats before making admission and will strictly follow the Merit list of VLDDDET-2024.

**Note: -**

- i) For **VLDD/DVLT Course** candidates allotted seat provisionally at **IPVS, LUVAS, HISAR**: Fees and other charges in total are to be deposited at fees counter of COVS, LUVAS, Hisar at the time of document checking. Otherwise, the seat will be declared vacant (see Gist of chargeable fee in Chapter V, ahead).
  - ii) For **VLDD Course** candidates allotted seat provisionally at the Affiliated Private Institutes/Colleges: Annual fee structure fixed by government of Haryana and “University registration fee and Administrative charges-cum-one year examination fees” [for state quota seat Rs 1,80,000/- and for management quota seat Rs 2,50,000/-] in the form of Demand Draft (DD) are to be deposited by all the candidates at the time of document checking at the fees counter of COVS, LUVAS, Hisar, otherwise, the seat will be declared vacant. Demand Draft is payable to **Director, IPVS, LUVAS, Hisar. Payment will only be accepted as Demand Draft (Mandatory)**. NEFT/RTGS will not be considered as a mode of fees. No applicant will submit the annual fee structure fixed by government of Haryana and “University registration fee and Administrative charges-cum-one year examination fees” before the provisional allotment of seat in diploma course. Advance payment if any, will be refunded at the end of admission process and after due audit reconciliation, if the applicant applies with proof for refund.
  - iii) See Annexure- XIII for contact numbers regarding enquiry of amount of Total Fee, funds and charges of Affiliated Private Institutes/Colleges. Balance hostel funds, etc., which are institutes specific, are to be paid at the college campus along with medical fitness certificate, where finally admitted. This is to be done, only after availing sliding of admission in Affiliated Private Institutes/Colleges and after issuing of final admission order, at the end of all counselling(s) as given in the schedule on university website.
21. Age: The candidates must have attained the age of 17 years as on 31<sup>st</sup> December, 2024. Candidates attaining 17 years on 1st January, 2025 or later will not be eligible. There is no upper age limit for candidates of all the categories (except in-service candidates).
22. A separate online application form will have to be filled for VLDD and DVLT each. Upload documents as per list given in Annexure-XVIII in online form for LUVAS admissions 2024-25 and pay Application Processing fees separately, if applying for both diploma courses (VLDD & DVLT).
23. DVLT admissions will be done based on the merit of marks obtained in NEET(UG)-2024. The candidate having obtained marks 1 and above will only be considered in merit.



24. VLDD admissions will be done based on the merit of marks obtained in VLDDDET-2024. The candidate having obtained marks 1 and above will only be considered in merit.
25. Candidate should regularly visit university website ([www.luvas.edu.in](http://www.luvas.edu.in)) for latest information related to admission, counselling schedule of Online/Offline and Mop-up counselling(s).



## महत्त्वपूर्ण जानकारी

1. आवेदन पत्र केवल विश्वविद्यालय की वेबसाइट (www.luvvas.edu.in) के प्रवेश पोर्टल पर उपलब्ध होगा।
2. विश्वविद्यालय में प्रवेश के लिए आवेदन करने से पहले हरियाणा निवास के उम्मीदवार का परिवार पहचान पत्र (पीपीपी आईडी यानी फैमिली आईडी) अनिवार्य है। आवेदन पत्र में उम्मीदवार का मूल विवरण यानी नाम, पिता का नाम, श्रेणी आदि पीपीपी आईडी से स्वतः प्राप्त हो जाएगा। यदि, पीपीपी आईडी से प्राप्त विवरण उम्मीदवार द्वारा बदला जाता है, तो उम्मीदवार को अपनी पीपीपी आईडी को सही विवरण के साथ अपडेट करवाना आवश्यक है। उम्मीदवार को दस्तावेज़ जाँच के समय अपडेटेड पीपीपी आईडी जमा करनी होगी।
3. आवश्यक न्यूनतम शैक्षणिक योग्यता: **VLDD** के सभी श्रेणियों के तहत उम्मीदवार Any stream के साथ 10+2 परीक्षा पास तथा मैट्रिक/10वीं कक्षा की परीक्षा में न्यूनतम 50% अंक के साथ उत्तीर्ण हों (अनुसूचित जाति/ वंचित अनुसूचित जाति के उम्मीदवार न्यूनतम 47.5% अंक के साथ उत्तीर्ण हों)।
4. IPVS, हिसार के DVLDT डिप्लोमा में प्रवेश पाने के इच्छुक सभी उम्मीदवार को प्रवेश, NEET(UG)-2024 में लिए गए अंको की वरीयता के आधार पर दिया जाएगा। IPVS, हिसार तथा संबंध निजी संस्थान/महाविद्यालयों में VLDD डिप्लोमा में प्रवेश पाने के इच्छुक सभी उम्मीदवार को प्रवेश, VLDD-2024 में लिए गए अंको की मैरिट के आधार पर दिया जाएगा।
5. उम्मीदवार ने 31 दिसंबर, 2024 को 17 वर्ष की आयु प्राप्त कर ली हो। उम्मीदवारों ( जीएनसीटी दिल्ली के फ्रेश उम्मीदवारों सहित ) की आयु 31.12.2024 को 17 वर्ष से कम नहीं होनी चाहिए। 1 जनवरी 2025 या उसके बाद 17 वर्ष की आयु प्राप्त करने वाले उम्मीदवार पात्र नहीं होंगे। 01.01.2008 या उसके बाद जन्मे उम्मीदवार पात्र नहीं होंगे।
6. प्रबंधन कोटे की सीटों के लिए, हरियाणा के आरक्षित श्रेणियों (अनुसूचित जाति/ वंचित अनुसूचित जाति) के उम्मीदवारों को राज्य कोटे की सीटों के तहत आवेदन करने वाले उम्मीदवारों के समान, अंको में छूट मिलेगी।
7. कृपया आवश्यक दस्तावेज़ सलंग्न करें, जैसा कि Annexure- XVIII में दिया गया है। फोटो अपलोड ठीक वैसी करें जैसी कि प्रॉस्पेक्टस 2024-2025 Annexure- XVII में मांगी गयी है। यदि दी गई जानकारी गलत है या सलंग्न किए गए दस्तावेजों के साथ मेल नहीं खा रही है और फोटो Annexure- XVII के निर्देशों के अनुसार नहीं है, तो आवेदन अस्वीकार कर दिया जाएगा।
8. सशस्त्र सीमा बल (SSB) तथा अन्य सभी सेवाओं के उम्मीदवार के द्वारा ऑनलाइन आवेदन पत्रकी फोटोकॉपी जमा करने की अंतिम तिथि उचित माध्यम से पहली काउंसलिंग शुरू होने कि तिथि से 7 दिन पहले होगी।

17. सभी संबंध निजी संस्थानो / कॉलेज के दाखिले (राज्य कोटा और प्रबंधन कोटा की सीटें) IPVS, LUVAS, हिसार में किए जाएंगे। संबंध निजी संस्थान / कॉलेज अपने स्तर पर कोई भी दाखिला देने के लिए मान्य नहीं हैं। काउंसलिंग, दस्तावेज़ जाँच, पंजीकरण आदि पशुचिकित्सा सभागार (Vety. Auditorium), पशुचिकित्सा महाविद्यालय (Vety. College) हिसार में किये जाएंगे। फोटो, फीस जमा करना तथा मेडिकल जांच पशुचिकित्सा महाविद्यालय (Vety. 19. **Chapter-I****INTERPRETATION OF RULES AND REGULATIONS**

In the event of any inconsistency in the Rules framed for admission policy or in the event of any clarification with respect to the Rules, the matter shall be referred to the Competent Authority and the interpretation of the Rules/guidelines as mentioned in the Prospectus shall be final. The Vice-Chancellor is competent to eliminate any inconsistency and decide as to which provision shall take precedence over the others.

**REMEDIES**

If an applicant has any grievance or is of the opinion that in his/her case, the rules framed for admission have not been followed, he/she may submit an application outlining clearly the grievance/deviation in his/her opinion to the Students' Grievance Redressal Committee (SGRC) through Registrar, LUVAS. The SGRC shall consider the application in the light of relevant rules. Aggrieved by the decision of SGRC, the students may appeal to the Ombudsperson through Registrar, LUVAS. All grievances/disputes even if not covered under guidelines/rules mentioned in the prospectus will be resolved by the competent authority.

**DISCLAIMER**

The statements made in this Prospectus and all other information contained herein are believed to be correct. However, the Competent Authority reserves the right to make additions and alternations in the regulations, corrections of any inadvertent clerical mistake, conditions governing admissions, the code of conduct of students, requirements for the diploma, fee and any other information or statement/Rule contained in this Prospectus, at any time without notice. The Competent Authority may drop/cancel any Diploma programme, indicated in the Prospectus, at any time without prior notice, reduce, or enhance the number of seats for reasons to be recorded in writing. No responsibility shall be accepted by the University for hardships or expenses incurred by the candidates or any other person for such changes, additions, omissions or errors, no matter how these were caused.

**JURISDICTION-** Jurisdiction for all disputes shall be at Hisar.



**Chapter-II****INTRODUCTION**

Two Diploma courses viz., Veterinary and Livestock Development Diploma (VLDD) and Diploma in Veterinary Laboratory Technology (DVLT) are offered by the Institute of Para Veterinary Sciences, Lala Lajpat Rai University of Veterinary and Animal Sciences, Hisar.

**MEANING AND SCOPE OF THE PROSPECTUS**

It is a brief compilation of information and not an exhaustive detail of all the regulations made by the competent authority in this regard. The provisions of the Prospectus are in the shape of guidelines which are available to the candidates seeking admission and do not in any manner limit the power of any Competent Authority in making additional regulations regarding the admission of the candidates in VLDD and DVLT courses.

Admissions are made in accordance with the admission rules/guidelines. Since it is not possible to mention detailed procedure and guidelines in the Prospectus, admission rules are to be read with the instructions issued/to be issued from time to time by the university. The candidates are advised to visit the university website ([www.luvass.edu.in](http://www.luvass.edu.in)) regularly for the updates.

**COMPETENT AUTHORITY**

The original jurisdiction to make regulations regarding the admission of the candidates in the VLDD and DVLT programmes is vested in the Board of Studies of College of Veterinary Sciences of Lala Lajpat Rai University of Veterinary and Animal Sciences, Hisar.

The provisions as reproduced in the Prospectus or the guidelines as provided in this Prospectus shall not make precedence over the powers of the Board of Studies of College of Veterinary Sciences as provided in Section 7 of Chapter II of the Act and Statutes and the powers of the Vice-Chancellor as contained in Section 21 of the Haryana Legislative Act No. 7, 2010 and any of the provisions of the Act 2010 and the subsequent Statutes framed by the University from time to time.

# The provisions or guidelines provided in the Prospectus are not final and are subject to modifications made by the Competent Authority or the State Govt. under the Act and Statutes and if superseded by such decision by the Competent Authority or the State Govt. under section 40(1&2) of LUVAS Act, the latter will prevail and the information given in the Prospectus shall stand modified to that extent automatically.

**THE UNIVERSITY**

Lala Lajpat Rai University of Veterinary and Animal Sciences (LUVAS) was established by Haryana Government (Haryana Act No. 7 of 2010 passed/enacted on 7<sup>th</sup> April, 2010). The University has been catering to the needs of Haryana and adjoining states pertaining to livestock health and production since 1<sup>st</sup> December 2010. The University has the following objectives:

- (a) To impart education in different branches of veterinary, animal sciences, fishery sciences and allied sciences as it may determine from time to time
- (b) To further advancement in learning and research in veterinary, animal sciences, fishery sciences and other allied sciences and to undertake extension of such specialized knowledge to the needy people





- (c) To undertake study in marketing strategies of live-stock and live-stock products, conservation of live-stock breeds and wild animals
- (d) To liaison and establish vital linkage with the concerned departments of Animal Husbandry, Fisheries and Dairy Development of the State Government and Union Government, National and International Research Institutes specialized in the field of veterinary, animal sciences, fishery sciences and allied sciences with a view to keep abreast of the latest technology
- (e) To raise level of veterinary study to International Standards
- (f) Such other objects, as the Board may determine, from time to time.

### **UNIVERSITY CAMPUS**

The main campus of the University is situated at Hisar at a distance of about 172 KM North-West of Delhi on National Highway No. 9 and is 2 Km from the railway station and 3 Km from the bus stand. New campus is being developed at a sprawling site on Barwala road in Hisar.

### **INSTITUTE OF PARA VETERINARY SCIENCES (IPVS)**

This Institute has been established by the University in February, 2014. The Director of the Institute is responsible for all the activities concerning admissions, rules, regulations, timetable, examinations, administrative, educational and financial aspects relating to the diploma courses being run by the university. The admissions and academic standards in the private institutes affiliated with the university will also be governed by the Director, IPVS, LUVAS, Hisar.

### **COLLEGE OF VETERINARY SCIENCES (COVS)**

The college has a legacy from Veterinary College at Lahore established in 1882. Initially, a Camp Veterinary College was established at Hisar in 1948. In 1970, it became a part of Haryana Agricultural University, Hisar. Now, it is the constituent college of LUVAS, Hisar. The college is a centre of regional, national and international excellence for learning in Animal Health and production. It caters to the needs of Haryana and adjoining states by carrying out teaching, research and extension education programmes pertaining to Veterinary and Animal Sciences.

The college has highly competent and experienced faculty with significant contributions in research and has won several national and international awards. This college has 18 departments having excellent laboratory facilities and adequate infrastructure for teaching, research and extension. A well-equipped Veterinary Clinical Complex (VCC) is catering to the needs of farmers and pet owners. Additionally, there are well-established Haryana Pashu Vigyan Kendras, Animal and Poultry Farms and a Disease-Free Small Animal House.

### **LIBRARY AND INFORMATION SERVICES**

This University is presently sharing the library and information services with CCS HAU, Hisar. The library is housed in a centrally located elegant building and it opens for 15-16 hours daily throughout the year. The library also has a Bookshop. The students can buy books from the Bookshop at discounted rates. Photocopying service is provided at nominal rates. Besides, LUVAS University library provides structural support to the departmental libraries of COVS, IPVS and CODST. It has good collection of e-books.



## DIRECTORATE OF STUDENTS' WELFARE-CUM-ESTATE OFFICER

The Directorate is responsible for the welfare of students and helps in their counselling and placement, cultural and sports activities. Presently, LUVAS is sharing the students' welfare facilities with CCSHAU, Hisar.

### i) **Giri Centre for Sports Activities**

The Giri Centre for students' sports activities is an outstanding feature. It has two indoor badminton courts, two indoor squash courts, hobby rooms and two multipurpose indoor gymnasiums. A synthetic track of international standard has also been provided in the athletic stadium.

### ii) **Co-curricular Activities**

The Directorate of Students' Welfare is also responsible for promotion of all the co-curricular activities such as sports, NCC, mountaineering, graphic arts, literary, music, dance, drama etc.

### iii) **Students' Counselling and Placement Cell**

The Counselling and Placement Cell of the university provides information to the students regarding job opportunities, competitive examinations, scholarships/fellowships, etc. It also conducts trainings/coaching classes for the entrance examinations, personality development and explores the job opportunities in the public and private sectors.

### iv) **Hostel Facilities**

**The University hostel has limited availability and allotment will subject to availability of rooms.** The students will be required to make their own arrangements of accommodation in case of non-availability of hostel. Hostels have all the facilities such as furniture, TV with cable connection, leading newspapers and magazines and solar water heating system. All the hostels have EPABX phone facilities as well as incoming calls facilities. Two hostel wardens look after the management of each hostel. Every hostel has been provided with water coolers having water purification system for safe drinking water. The hostel mess is being run on co-operative basis.

## MEDICAL FACILITIES

This facility is presently shared with CCSHAU, Hisar. There is a well-equipped 50 bed hospital in the Campus. Medical aid is provided round the clock to the students and staff.



## Chapter-III

**RULES AND REGULATIONS GOVERNING  
ADMISSIONS TO DIPLOMA COURSES****1. ELIGIBILITY AND APPLICATION FORM**

1.1 The minimum educational qualifications for eligibility are different for VLDD and DVLT courses. Application forms for VLDD and DVLT are separate. VLD Diploma Entrance Test (VLDDDET-2024) is conducted by LUVAS. DVLT diploma candidate shall have to appear in the test to be conducted by NTA for NEET (UG)-2024 for admission. One can apply for both the Diploma courses, separately, along with the required fee.

1.2 **Minimum educational qualifications for admission to VLDD and DVLT Courses:**

i) For Admission to **VLDD** Course:

The candidates under all categories must have passed 10+2 examination in **Any Stream (as per instructions vide letter no. 3350(CFMS)-AH-5-2024/4831 dated-21.08.2024 of Additional Chief Secretary to Govt. Haryana, Animal Husbandry and Dairying Department)** and matriculation/10<sup>th</sup> standard examination with a minimum of **50% marks (except for SC/DSC category)** from a recognized/approved board of school education having equivalence by Council of Boards of School Education (COBSE), New Delhi /CBSE/ICSE/Board of School Education Haryana, Bhiwani. **As per Chief Secretary to Government of Haryana letter no. 22/129/2013- 1GSIII Dated 16.07.2014, the SC/DSC category candidates will be allowed a relaxation upto 5% of the requirement for General Category i.e. the SC/DSC candidates securing a minimum of 47.5% marks in 10<sup>th</sup> standard examination will be eligible to apply for admission.**

**For management quota seats, the Haryana domiciled SC/DSC, candidates will get the same relaxation in eligibility marks as the candidates applying under state quota seats.**

**Note: A bridge course will be introduced only for the students who get enrolled in the VLD diploma course from non-science category in IPVS, LUVAS and all affiliated private colleges/institutes of LUVAS. This course of three months duration will be carried out simultaneously at the start of first year.**

ii) For Admission to **DVLT** Course:

All the candidates seeking admission to DVLT course of IPVS, Hisar must have appeared in the NEET (UG)-2024 to be conducted by National Testing Agency (NTA). The candidates under all categories must have passed 10+2 examination in **Medical stream (Physics, Chemistry, Biology/Biotechnology as main subjects)** and obtained a minimum of **50% marks (except SC/DSC category) in aggregate of English, Physics, Chemistry and Biology/Biotechnology subjects** from a recognized/approved Board of School Education having



equivalence by Council of Boards of School Education (COBSE), New Delhi/CBSE/ICSE/Board of School Education Haryana, Bhiwani. **As per Chief Secretary to Government of Haryana letter no. 22/129/2013-1GSIII Dated 16.07.2014, the SC/DSC category candidates will be allowed a relaxation upto 5% of the requirement for General Category i.e. the SC/DSC candidates securing a minimum of 47.5% marks in aggregate of the four subjects mentioned above in 10+2 examination will be eligible to apply for admission.**

- 1.3 **The candidate must have attained age of 17 years as on 31<sup>st</sup> December, 2024.** The candidates (including fresh candidates of GNCT Delhi) should not be less than 17 years of age as on 31.12.2024. Candidates attaining age of 17 years as on 1<sup>st</sup> January 2025 or later will not be eligible. Candidates born on 1.1.2008 or later will not be eligible. There is no upper age limit for all the candidates (except in-service).
- 1.4 The list of boards/universities that are un-recognised/un-approved/not found equivalent by Board of School Education Haryana/CBSE/ICSE and Council of Boards of School Education, New Delhi is given as Annexure-XIV. Later on, if any other board/university is not found equivalent for 10<sup>th</sup> and/or 10+2, the certificate issued by such a board/university will be invalid and the candidates possessing such certificate will not be eligible for the admission. Inadvertently, if any such candidate is admitted his/her admission shall be cancelled at any time by the Director, IPVS besides taking disciplinary action as per Rules. Recognized board refers to that it should be a member of Council of Boards of School Education, New Delhi and must be created by an Act of State Legislature or Parliament.
- 1.5 In case, the result of the qualifying examination has been declared publicly but the certificate has not been issued by the concerned board/university, such candidates shall have to produce certificate (See Annexure-IX) from the Head of institute last attended.
- 1.6 The last date for submission of online duly filled application form alongwith documents as enlisted in Annexure-XVIII for all the **VLDD** seats of IPVS, LUVAS, Hisar and the Affiliated Private Institutes/Colleges on the University website is **30-09-2024** without late fee and **04-10-2024** with late fee of Rs.600/-.
- 1.7 **The coloured photograph of size 2.0" x 2.0" (taking photo on or after 01-05-2024) to be uploaded with the application form should depict the name of candidate and date of taking photo (See Annexure-XVII). The focus must be on face (80% face coverage with full clarity, ears clearly visible, with white background). The candidate should not be wearing cap or goggles while getting photographed.**

Spectacles are allowed, only, if being used regularly.

Polaroid and Computer/mobile-generated photos are not acceptable.

The application of candidates who upload the computer/mobile generated photographs or with any other specification not covered in these instructions (See Annexure-XVII) will be rejected. Applications not filled in with these instructions or if the 2.0" x 2.0" size photograph is old or with cap or dark glasses or disfigured or with unclear photographs are liable to be rejected. Application without photographs shall be rejected.



Candidates are advised to keep 6 to 8 passport size coloured photographs of the same photograph as uploaded with the application. Admit Card is to be downloaded by the candidate from the university website. After downloading the admit card, the candidate should affix a similar 4”X6” size coloured photograph.

Candidates may note that if the photographs uploaded are found to be fabricated i.e. deshaped or seem to be hand-made or computer made, his/her candidature will be rejected and the same would be considered as using Unfair Means and the candidate would be dealt with accordingly as per Rules and law.

## 2. ENTRANCE TEST (VLDD-2024)

### For VLDD

- 2.1 All the VLDD applicants including in-service candidates (except employees of SSB) shall have to appear in VLDD-2024 on **27-10-2024**.

SSB Candidates can apply online or offline and report for document checking at the time of admission/counselling and pay “Application Processing fees and other charges” in total there and then.

All the **in-service applicants** including those from **SSB** have to submit photocopy of the filled online application form alongwith the required documents **through proper channel** to the Director, IPVS, LUVAS, Hisar latest by **7 days prior to 1<sup>st</sup> counselling** otherwise their candidature will not be considered for admission.

- 2.2 Applicants who have appeared in 10+2 or equivalent examination (even if result is yet to be declared) may also appear in VLDD-2024, however, such candidates will be considered for admission on merit basis of VLDD-2024 provided they fulfil the eligibility conditions as given under Rule 1 of this Chapter and on production of all the original documents (coloured photocopy of documents will not be accepted) at the time of counselling/document checking.

- 2.3 VLDD-2024 Pattern and Syllabus:

- 2.3.1 **Details of the subjects of the Diploma Entrance Test (VLDD-2024) are as under:**

**Note:** 1. The syllabus for VLDD Entrance Test- 2024 will be of Matric standard of Board of School Education, Haryana/CBSE, New Delhi.

**2. As per letter no. 3350 (CFMS)-AH-5-2024/4831 dated-21.08.2024 of Additional Chief Secretary to Govt. Haryana, Animal Husbandry and Dairying Department.**

- 2.3.2 The admissions to all the seats in VLDD (except SSB) will be made through Online/Offline and Mop-up counselling(s) as per the merit list to be prepared on the basis of marks obtained by the candidates in VLDD-2024 to be conducted by LUVAS. Applicants from **SSB** have option to apply offline and pay application processing fee of Rs 2000/- at IPVS, LUVAS, Hisar.



**2.4 General Instructions for the Entrance Test:**

- i) Total duration of the Diploma Entrance Test (VLDDDET-2024) will be 2 hrs and 15 minutes (initial 30 minutes are for completing pre-examination formalities and remaining 1 hour 45 minutes for solving the question paper).  
The timings of the entrance test and reporting time will be **notified on university website later on.**
- ii) Medium of question paper for **VLDDDET-2024 will be English and Hindi both.**
- iii) There will be no negative marking.
- iv) Admit Card is to be downloaded by the candidate from the university website. After downloading the admit card, the candidate should affix a similar 4”X6” coloured photograph (photo as uploaded on the application form, See Annexure-XVII), taken on or after 01.05.2024, in the space provided on the admit card. The admit card will be retained by the University at the Test Centre.
- v) Entry to the Test Centre will not be allowed without a valid website generated Admit Card as mentioned above. Entry will be allowed only when the candidate is having the same identity of face as in the photo, which was uploaded in the online application form.
- vi) While coming for the VLDDDET-2024, the candidates must follow the instructions strictly, which are to be downloaded alongwith the admit card.
- vii) Electronic devices such as bluetooth, calculator, mobile phone etc. are not allowed in the examination centre.
- viii) Before using the OMR sheet, the candidate must carefully check the question booklet and OMR sheet and report the short comings, if any, to the supervisory staff. Once the candidate has written/filled in the OMR sheet, no replacement shall be allowed.
- ix) Cutting(s)/over-writing(s)/using erasing fluid/erasing tape/white fluid etc. are not allowed on OMR sheet. Such answers will not be evaluated.
- x) The OMR sheet should not be folded and no rough work is allowed to be done on OMR sheet.
- xi) Every candidate will be required to put his/her thumb impression (Boys-Left, Girls-Right) on the attendance sheet during the VLDDDET-2024 and if this thumb impression will not match at the time of counselling & document checking, the admission to the candidate will be refused.

**2.5 Penalty for use of unfair means in the Diploma Entrance Test:**

- i) Candidate(s) found guilty of using unfair means or misconduct (as defined below) shall be expelled from the VLDDDET-2024 by the Centre Superintendent/Director, IPVS and his decision shall be final.
  - a. Creating disturbance of any kind during the Diploma Entrance Test or otherwise misbehaving in or around the VLDDDET-2024 centre or refusing to obey the Superintendent/Supervisor/Invigilator, etc. or changing his/her seat with any other candidate.
  - b. Having in his/her possession or accessible to him/her papers/books/notes/mobile phone which may possibly be of any assistance to him/her or found giving or



receiving assistance or copying from any paper/book/notes, etc. or allowing any other candidate to copy from his/her OMR sheet or found writing on a paper other than his/her question booklet or OMR sheet or using or attempting to use any other unfair means during the VLDDDET-2024.

- c. Tempering with his/her roll number or name on the OMR sheet.
- d. Using cellular phone/blue tooth or any such electronic device during the VLDDDET-2024.
- ii) Any candidate found impersonating for another candidate or found being impersonated by another candidate during the VLDDDET-2024, apart from expulsion from the VLDDDET-2024, shall be **debarred from seeking admission to any programme of this University forever** and a criminal case may be registered with the local police.
- iii) If use of unfair means is detected at the time of evaluation of OMR sheets/counselling or there after, or any complaint (anonymous/pseudoanonymous) is received after admission and it is proved to be correct after an enquiry, the candidate shall be disqualified and his/her admission will be cancelled as the case may be and he/she will be debarred from seeking admission in any programme of this University forever.

2.6 The result of the VLDDDET-2024 shall be available on the University website and will not be communicated to any individual candidate.

2.7 There is no provision for re-checking or re-evaluation of OMR (answer sheets) and no enquiry or request in this regard shall be entertained.

#### 2.8 **Same marks in the entrance test or otherwise (Tie-Breaker)**

In case of two or more candidates scoring the same marks in the VLDDDET-2024 for VLDD, the merit amongst these candidates will be decided on the basis of percentage of aggregate marks obtained in **10+2 examination**. If still, there is a tie then the merit amongst these candidates will be decided on the basis of percentage of marks obtained in **Matriculation examination**. If still, there is a tie then the candidate **senior in age** will be considered higher in the merit.

#### 2.9 **NEET(UG)-2024 For DVL T**

All the candidates (Haryana residents, J&K applicants, and in-service candidates) seeking admission to DVL T course at IPVS, LUVAS, Hisar must have appeared in the NEET(UG)-2024 conducted by NTA.

Applicants who have appeared in 10+2 or equivalent examination with required subjects (even if result is yet to be declared) may also apply. However, such candidates will be considered for admission on the basis of merit of NEET(UG)-2024 provided they fulfil the eligibility conditions as given under Rule 1 of this Chapter above and production of all the original documents (coloured photostat of documents will not be accepted) at the time of document checking (enlisted in 3.13 of this Chapter).

#### **Same marks in the NEET(UG)-2024 or otherwise:**

In case of two or more candidates scoring same marks in the NEET (UG)-2024, the merit would be decided on the basis of percentage of aggregate marks obtained in the subjects of English, Physics, Chemistry and Biology/Biotechnology of 10+2



examination. If still, there is a tie, then the candidate senior in age will be considered higher in the merit.

### 3. COUNSELLING-CUM-ADMISSION

#### General Rules:

- 3.1 The competent authority reserves the right to reject any application form and the reasons may be recorded in writing. Any grievance will be dealt as per point 3.10 of Chapter-III of this Prospectus.
- 3.2 The allocation of seats will be through Online/Offline and mop up counselling(s) and details will be available on university website. State and management quota seats in Affiliated Private Institutes/ Colleges will be filled up by the IPVS, LUVAS for first two counsellings. All the admission orders in constituent and Affiliated Private Institutes/Colleges will be made by Admission Committee for admissions to diploma courses, LUVAS, Hisar.
- 3.3 **The candidates have to fill preferences of Colleges/Institutes at the time of filling of application form and the preferences once submitted will be applicable for all online counsellings.** The candidates can fill as many as preferences but it shall not be compulsory for candidate to opt for all colleges options. If candidate is allotted seat in any online counselling and he/she doesn't want upgradation then he/she has to give in writing at the time of document checking. If the college of admitted candidate is upgraded in the next counselling as per his/her preference then he/she has to report for that counselling in-person for confirmation of his/her upgradation. If such upgraded candidate doesn't report in-person then he/she will lose his/her right of admission and he/she will be considered only in mop-up counselling.
- 3.4 The admission to all the seats of DVLT will be made as per the merit list to be prepared on the basis of marks obtained in NEET (UG)-2024 conducted by NTA. The admission to all seats of VLDD will be made as per the merit list to be prepared on the basis of marks obtained by the candidates in VLDDDET-2024 to be conducted by the LUVAS. Admission to both the diploma courses is open for male, female and transgender candidates. **The Diploma courses are open to Haryana Residents only, except for additional seats for IPVS, LUVAS.** Other state candidates can apply only for management quota seats in Affiliated Private Institutes/Colleges. The Haryana resident candidates will be considered first for admission and the other state candidates will be considered thereafter for admission to management quota seats based on the marks obtained in VLDDDET-2024.
- 3.5 All the seats at IPVS, LUVAS and State Quota seats of Affiliated Private Institutes/Colleges will be filled up by the **roster system** as indicated in **letter no. 22/10/2013-1GSIII dated 15.07.2014 of Government of Haryana and instruction(s) received from time to time from Government of Haryana.**
- 3.6 Admission to management quota seats of Affiliated Private Institutes/Colleges will be made by the Admission Committee for admissions to diploma courses, LUVAS on the basis of combined merit list of VLDDDET-2024 up to first two counsellings.
- 3.7 Admissions to VLDD seats reserved for Kashmiri Migrants and J&K Residents, additional seats reserved for GNCT Delhi, in-service candidates of LUVAS, AH &





DD Haryana, wards of regular employee of LUVAS and candidate of village Riwasa of Distt Mahendergarh at IPVS, LUVAS, Hisar will be made on the basis of merit list of VLDDDET-2024. Admission to DVLT seats reserved for Kashmiri Migrants and J&K Residents and in-service applicants at IPVS, LUVAS, Hisar will be made on the basis of merit list of NEET (UG)-2024.

- 3.8 The candidates, who have been allotted seats as per the merit list in the respective category, are to report for document checking and other admission formalities as per the schedule to be uploaded on the university website in the **Veterinary Auditorium of College of Veterinary Sciences, LUVAS, Hisar, failing which they will have no claim for admission. No separate letter in this connection shall be issued.**
- 3.9 The candidate shall have to pay annual fees fixed by Government of Haryana and “University registration fee and Administrative charges-cum-one year examination fees” there and then in the form of a single Demand Draft (as given on page 06, serial number 2), payable to Director, IPVS, LUVAS, Hisar, otherwise the seat will be declared vacant. If any candidate after completion of counselling/admission formalities does not deposit the required fees, then his/her candidature will be cancelled and he/she will not be eligible for subsequent online counselling(s). Also, if any candidate remains absent at the time of document checking, medical examination and fee deposition, he/she will not be considered in the subsequent online counseling(s) even if he/she is higher in merit. Further, if a candidate refuses to accept admission on his/her turn, he/she shall lose his/her right of admission in subsequent online counselling. However, such candidate(s) may participate in mop-up counselling(s), if any. **Those candidates who have already taken admission in IPVS, LUVAS or any other private affiliated college/institute will not be eligible for mop-up counselling of IPVS, LUVAS (if any).** See Annexure-XIII for enquiry of total fee structure of Affiliated Private Institutes/Colleges. Balance fees, charges, hostel funds, other dues, etc., which are institute specific, are to be paid at the college campus where finally admitted, after availing sliding of college admissions in Affiliated Private Institutes/Colleges and after issue of final admission order by the Admission Committee at the end of all counsellings as given in schedule.
- 3.10 **The candidate is required to bring all the original documents** (coloured photostat of documents will not be accepted), **two recently taken photos (See Annexure-XVIII) and two sets of self-attested photocopies of documents, etc. as per Rule 3.13 of this Chapter at the time of document checking at COVS, LUVAS, Hisar, failing which he/she may be refused admission.** If the category/income certificate or any other document is found to be false at the time of document checking, the candidate will be debarred from online counselling(s) and will be considered in the mop-up counselling as per University rules. The original documents of the candidates admitted to these Diploma courses shall be retained by the office of the Director, IPVS Hisar so as to get these verified from the Board/University/Office concerned after admission of the students. These documents will be returned to the candidates after completion of verification process. The original documents may be temporarily provided to the candidate on written request for a week or up to one day before the subsequent counselling, whichever is earlier, and if not returned back by the date committed, admission of that candidate shall stand automatically cancelled and seat will be declared vacant. However, as per State Govt. **letter no. 5084(CFMS)-AH-4-2024/5319 dated-**



**13.09.2024 of Additional Chief Secretary to Govt. Haryana, Animal Husbandry and Dairying Department**, if any seat remains vacant even after the 2<sup>nd</sup> counselling for filling up seats for admission to VLDD programme in the affiliated private college than the vacant seats shall be filled up by the concerned affiliated private college through the Merit list of VLDDDET -2024 examination. The college shall widely publicise the vacant seats before making admission and will strictly follow the Merit list of VLDDDET-2024.

**The Admission Committee for diploma courses will be as under: -**

1. Director IPVS, LUVAS, Hisar-Chairman
  2. One Faculty member to be nominated by Dean COVS, LUVAS, Hisar for VLDD/whereas Nodal officer, DVLTL for DVLTL-Member
  3. One Professor to be nominated by the Vice-Chancellor-Member
  4. One Representative of Additional Chief Secretary, Animal Husbandry and Dairying Department, Haryana- Member
- 3.11 The candidates for diploma courses at IPVS, LUVAS, Hisar, shall get themselves medically examined from Senior Medical Officer at the University Hospital, CCS HAU, Hisar. If found medically fit, he/she will deposit the medical fitness certificate alongwith the required fee on the same day in the O/o Dean, COVS. The candidates found to be medically unfit will not be admitted.

The candidates offered seat in the Affiliated Private Institutes/Colleges will be medically examined by Medical Officer(s) available at COVS, LUVAS on payment of medical examination fees, in cash up to first two counsellings. If found medically fit, he/she will deposit the annual fee structure fixed by Government of Haryana and “University registration fee and Administrative charges-cum-one year examination fees” on the same day in the O/o Dean, COVS. The candidates offered seat in the Affiliated Private Institutes/Colleges will submit the medical certificate at the campus of the Affiliated Private Institutes/Colleges, where they have been admitted, on date specified in counselling schedule, after last scheduled counselling. The admission of those candidates, who fail to complete any of the admission formalities, shall stand cancelled and on the request of the candidate the dues deposited shall be refunded as per rules.

3.12 **The completion of admission process involves the following:**

- i) Checking and submission of all the original documents along with self-attested photocopies as indicated under Rule 3.13 (in this chapter) at the time of counselling/document checking at IPVS, Hisar.
- ii) Medical fitness examination.
- iii) Deposition of total fees in the form of Demand Draft as given in Chapter-V.
- iv) Final Admission order by the Admission Committee for diploma courses of LUVAS

- 3.13 **Original and two sets of self-attested photocopies of the following documents** are required to be deposited to the document checking committee at the time of counselling and **failure to produce any of the original documents may make the candidate ineligible for the admission** (Coloured photostat of documents will not be accepted):



- i. Matric Certificate with Date of Birth and Father's/Mother's name.
- ii. The 10+2 certificate from Board of School Education, Haryana/CBSE/ICSE any other Board considered approved/equivalent as member by COBSE, New Delhi. If any certificate is found fake or not equivalent by any of the above Boards at any stage, the admission will be cancelled and legal action will be initiated. In case result has been declared publicly but the certificate of qualifying examination has not been issued by the concerned Board/University, such candidates shall have to produce a certificate (See Annexure-IX) from the Head of the Institute last attended.
- iii. Haryana Resident Certificate or Riwasa Resident Certificate as applicable (See Annexure-I & II a), GNCT Delhi Resident Certificate (See Annexure-IIb), if required.
- iv. Character Certificate (CC) from the institute last attended.
- v. Seat allotment letter downloaded from the university web site for online counselling for admission in Diploma courses.
- vi. The applicants who have passed the qualifying examination earlier and if there is a gap of more than one year (except for in-service candidates) from the date of declaration of result of the previous examination (other than the pursuit of studies in an institution/college) shall give a self-undertaking regarding their non-enrolment in any institution (See Annexure-X). Similarly, the applicants who have passed the qualifying examination as private candidates will also have to submit the undertaking in this regard.
- vii. Relevant certificate, if the benefit of reserved category/additional seat is being claimed (See Annexure-III to XXI), as the case may be. The candidates claiming reservation under BC categories are required to submit latest Income Certificate issued on or after **01-04-2024** along with category certificate as per Annexure-IV and IVa. The candidates claiming reservation under EWS category are required to submit the Income and Assets Certificate issued on or after **01-04-2024** as per Annexure-VI.
- viii. Candidates claiming reservation under Deprived Scheduled Castes shall have to submit, at the time of document checking, Deprived Scheduled Caste Certificate (See Annexure-XIX) issued by the competent authority.
- ix. Two coloured photographs of size 2"x2" (**taken on or after 01-05-2024**), which should be the same as uploaded on the online application form (See Annexure-XVII) at the time of counselling.
- x. Copy of Aadhar card.
- xi. Updated Parivar Pehchan Patra (Family ID).
- xii. The candidates claiming admission against the seats for Kashmiri Migrants are required to submit the Kashmiri Migrant Certificate issued by the competent authority.
- xiii. The candidates belonging to Jammu and Kashmir State are required to submit Jammu & Kashmir State Resident Certificate issued by the competent authority.
- xiv. Copy of the admit card of 10+2 class issued by the concerned education board.
- xv. Admit card issued by NTA for NEET (UG)-2024 examination (for DVLТ only).
- xvi. Score card depicting marks obtained in NEET (UG)-2024 examination (for DVLТ only).
- xvii. In-service Candidate Certificate (See Annexure-VIII) is to be attached in original failing which the application will be rejected. Certificate should be issued by:



- a. HOD for the in-service candidates of LUVAS.
- b. Director/Deputy Director, Animal Husbandry and Dairying for in-service candidates of Animal Husbandry & Dairying Department of Haryana.
- c. Director/Deputy Director, Animal Husbandry and Dairying GNCT Delhi for in-service as well as fresh candidates of GNCT Delhi.

The affidavit, wherever required, is to be submitted in original.

- 3.14 The applications of those candidates who are not admitted even in last counselling shall be destroyed after six months barring those related to the court cases/RTI matter, if any.
- 3.15 The record of VLDDDET-2024/counselling-2024 shall be destroyed after six months of last counselling except those related to any pending court cases/RTI matter.

#### **4 FOR IN-SERVICE CANDIDATES FOR ADMISSION TO VLDD COURSE THROUGH VLDDDET-2024 AND DVLTT THROUGH NEET (UG)-2024:**

##### **4.1 For In-service candidates of LUVAS, Hisar:**

- a) Educational qualifications are the same as mentioned under Rule 1, Chapter III.
- b) He/she should be serving on any of the posts as mentioned in Rule 4 (i) of Chapter IV for VLDD candidates, Rule 4(ii) of Chapter-IV for DVLTT candidates.
- c) He/she should have a minimum of 3 years' experience of working on any of the posts mentioned in Rule 4 (i and ii) of Chapter IV in LUVAS as on the last date of submission of application form.
- d) He/she should have a good service record.

##### **4.2 For In-service candidates of Animal Husbandry & Dairying Department, Government of Haryana & for AHD, GNCT Delhi.**

- a) Educational qualifications are the same as mentioned under Rule 1, Chapter III.
- b) He/she should be serving on any of the posts as mentioned in Rule 4(iii) and 4(iv) of Chapter-IV, respectively.
- c) He/she should have a minimum of 3 years' experience of working on any of the posts mentioned in Rule 4 (iii and iv) of Chapter IV as on last date of submission of application form.
- d) He/she should have a good service record.

##### **4.3 For Fresh candidates of GNCT, Delhi:**

- a) Educational qualifications are the same as mentioned under Rule, Chapter III.
- b) Annexure-IIb from SDM/competent authority and Annexure-VIII from Director, AHD, GNCT Delhi for fresh candidates.

##### **4.4 For in-service candidates of Sashastra Seema Bal (SSB) without appearing in VLDDDET-2024:**

- a) Educational qualifications are the same as mentioned under Rule 1, Chapter III.
- b) He should be employed as a Constable (Veterinary).
- c) He should have a good service record.

**Note:** Admission will be made strictly on merit and the same will be determined based



on the marks obtained in the respective Entrance test. However: -

- a) For the candidates of GNCT Delhi, first preference will be given to in-service candidates of AHD, GNCT Delhi and if seats remain vacant, the fresh candidates of GNCT Delhi will be admitted.
- b) For the candidates of village Riwasa of district Mahendergarh, the candidates will be first considered for admission in the General or any of the reserved categories to which he/she belongs as per his/her merit in the VLDDDET-2024 on the production of valid certificates of his/her category at the time of counselling.

**4.5 For in-service candidates of LUVAS/ Animal Husbandry and Dairying Department, Haryana/ AHD GNCT, Delhi and one seat of village Riwasa of district Mahendergarh.**

- i) Admission will be made strictly on merit and same will be determined based on the marks obtained in VLDDDET-2024.
  - ii) Reservation of seats (roster system) is not applicable here.
  - iii) All applicants for one additional seat of village Riwasa of district Mahendergarh **will report in person** at LUVAS, Hisar **on 1<sup>st</sup> counselling scheduled** for VLDD course for verification of residence proof of village Riwasa as certified by Sarpanch of village Riwasa of district Mahendergarh (See Annexure-IIa) along with other essential documents.
5. List of derecognized/unrecognized Boards and fake Universities has been given as Annexure-XIV of this prospectus. Equivalence and acceptability of certificates/examinations/degrees, etc. for the purpose of admission to VLDD/DVLT courses will be decided by the Admission Committee. The decision of the Committee will be final.
  6. At the time of admission, the Admission Committee shall also consider the past record of the candidate, concerning his/her conduct as a student/employee in this University or elsewhere. If the authority is satisfied that the applicant/ student/ employee, as the case may be, being considered for admission was involved in any act(s) of indiscipline, organizing demonstration(s), involvement in criminal offence(s) specially involved in immoral activities, the Admission Committee may refuse admission to such candidates.
  7. A candidate aggrieved by any decision of the Admission Committee may appeal within three days to the Vice-Chancellor, LUVAS, Hisar who will examine the application with reference to Rules and regulations and decision of the Vice-Chancellor, in the matter, shall be final.

**Note:**

- i. The duration for appeal has been kept short as in the matters of admission, a time bound schedule is to be followed.
- ii. Admissions to the Diploma programmes will be made by the Director, IPVS, LUVAS, Hisar. The Director, IPVS shall accordingly register the students after payment of the prescribed fees and other charges. If it is found, at any time, that a candidate has obtained admission to this programme by misrepresentation of facts or that candidate has availed some benefit, which was not due to him/her or if a candidate has been admitted due to an error, the Director, IPVS may at his discretion, cancel his/her admission to the Diploma Programme.
- iii. Admission remains provisional. Documents submitted by the candidates shall be checked/ got verified/ re-verified from the concerned board at any time during the course of study. If, at any stage, any certificate is found fake or not equivalent by



Board of School Education, Haryana/CBSE/ICSE/any other Board considered approved/equivalent as member of COBSE, New Delhi, admission will be cancelled and legal action will be initiated.

8. Director IPVS, LUVAS, Hisar is authorised to indicate need-based changes in schedule & scheme of counselling/admission with due information well in advance, on the University website, **[www.luvas.edu.in](http://www.luvas.edu.in)**.



## Chapter-IV

## ADMISSION CAPACITY IN DIPLOMA COURSES AT IPVS, LUVAS HISAR & THE AFFILIATED PRIVATE INSTITUTES/COLLEGES

### 1. ADMISSION CAPACITY IN DIPLOMA COURSES

**3. DEFINITION OF PERSONS WITH DISABILITY:**

Applicant having permanent disability of not less than 40%, provided the applicant is otherwise fit for a VLDA/LT's (Laboratory Technician) duty. Such applicant will have to bring a valid disability certificate from such a Medical Board (See Annexure-V) from the Chief Medical Officer of the District to which the candidate belongs.

Such candidates will also have to appear before the medical board of LUVAS for determining the percentage of disability and for assessment whether they are fit to carry out the duties of a Veterinary & Livestock Development Assistant (VLDA)/Laboratory Technician (LT) despite being handicapped. The findings of the university Board shall be final, superseding the certificate already submitted by the applicant.

A candidate shall not be allowed admission to VLDD course if he/she suffers with any kind of mental disability or the disabilities in physical fitness as listed below:

- i) Disability of total body including disability of chest/spine more than 50%.
- ii) Disability of lower limb of more than 50%.
- iii) Disability of upper limb.
- iv) Visually handicapped candidates and those with hearing disability.
- v) Candidate with progressive disease like Myopathies etc.



- vi) Disabilities which otherwise would interfere in the performance of the duties of a VLDA/LT.

##### For wards of regular employee of LUVAS: VLDD Course

**Eligibility:** The Candidate must have passed 10+2 examination in Any stream and matriculation/10<sup>th</sup> standard examination with a minimum of 50% marks from a recognized/approved board of school education having equivalence by Council of Boards of School Education (COBSE), New Delhi /CBSE/ICSE/Board of School Education Haryana, Bhiwani. The candidate should not be less than 17 years of age as on 31.12.2024. The candidate seeking admission under this category is required to submit Annexure-XXI. Then benefit of additional seat for wards of regular employee of LUVAS will be offered on merit in VLDDDET-2024.

##### ii) For in-service candidates of LUVAS: DVLT Course

**Eligibility:** Only the Lab. Staff working on the following posts will be considered: Lab. Attendant, Lab. Assistant and Senior Lab. Assistant, the candidate should possess the required minimum eligibility qualifications as mentioned under Rule 1 of Chapter–III.

##### For wards of regular employee of LUVAS: DVLT Course

**Eligibility:** The candidates seeking admission to DVLT course of IPVS, Hisar must appear in the NEET (UG)-2024 to be conducted by National Testing Agency (NTA). The candidate must have passed 10+2 examination in Medical stream (Physics, Chemistry, Biology/Biotechnology) and obtained a minimum of 50% marks in aggregate of English, Physics, Chemistry and Biology/Biotechnology subjects from a recognized/approved Board of School Education having equivalence by Council of Boards of School Education (COBSE), New Delhi/CBSE/ICSE/Board of School Education Haryana, Bhiwani. The candidate should not be less than 17 years of age as on 31.12.2024. The candidate seeking admission under this category is required to submit Annexure-XXI. Then benefit of additional seat for wards of regular employee of LUVAS will be offered on merit in NEET(UG)-2024.

##### iii) For in-service candidates of the Animal Husbandry and Dairying Department, Government of Haryana: VLDD Course

The candidate should not be less than 17 years of age as on 31.12.2024. The candidate seeking admission under this category is required to submit Annexure-IIa. Then benefit of additional seat for village Riwasa of district Mahendergarh will be offered on merit in VLDDDET-2024.

**vi) For J&K Residents**

Candidates from Jammu & Kashmir: **The Principal Secretary to Government of Haryana, Department of Higher Education has notified vide memo no. 23/09-2017 Coordination (3) dated 01.06.2017 that the State Government of Haryana has decided to provide the following concessions to the students belonging to Jammu & Kashmir for their admission in the colleges and universities of Haryana:**

**ANNEXURE-XVI****RULES REGARDING PREVENTION OF RAGGING****Title, Commencement and Applicability**

These Rules shall be called the “Lala Lajpat Rai University of Veterinary and Animal Sciences Rules on Curbing the Menace of Ragging, 2013” The University has adopted the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 as well as the directions of the Hon’ble Apex Court.

They shall apply to all the students enrolled in certificate, diploma, UG and PG degree programmes or any other category of courses in which instruction/education is imparted by the Lala Lajpat Rai University of Veterinary and Animal Sciences and which includes its departments, constituent/affiliated private colleges and all the premises, whether being academic, residential, playgrounds, canteen or other such premises of the University whether located within the campus or outside/outstations/Research Stations and to all means of transportations of students, whether public or private, accessed by students for the pursuit of studies in this University.

**Objectives**

To prohibit any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student; and thereby, to eliminate ragging in all its forms from this University, by prohibiting it under these Rules, preventing its occurrence and punishing those who indulge in ragging as provided for in these Rules and the appropriate law in force.

**What constitutes Ragging**

Ragging constitutes one or more of any the following acts:

- a. Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- b. Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- c. Asking any student to do any act which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;





- d. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher;
- e. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students;
- f. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
- g. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- h. Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student;
- i. Any act that affects the mental health and self-confidence of a fresher or any other student. With or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

### **Anti-Ragging Committee**

To be proposed by the DSW and headed by the Registrar, and consisting of representatives of civil and police administration, local media, Non-Government Organizations involved in youth activities, representative of faculty members, representatives of parents, representatives of students belonging to the fresher category as well as senior students, non-teaching staff; and shall have a diverse mix of membership in terms of levels as well as gender. Action to be taken by the Dean /Principal of the Constituent Colleges on receipt of the recommendation of the Anti-Ragging Squads or on receipt of any information concerning any reported incident of ragging, the Deans/Principal shall immediately determine if a case under the penal laws is made out and if so, either on his own or through a member of the Anti-Ragging Committee authorized by him in this behalf, proceed to file a First Information Report (FIR), within twenty four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely:

- i) Abetment of ragging;
- ii) Criminal conspiracy to rag;
- iii) Unlawful assembly and rioting while ragging;
- iv) Public nuisance created during ragging;
- v) Violation of decency and morals through ragging;
- vi) Injury to body, causing hurt or grievous hurt;
- vii) Wrongful restraint;
- viii) Wrongful confinement;
- ix) Use of criminal force;
- x) Assault as well as sexual offences or unnatural offences;
- xi) Extortion;



- xii) Criminal trespass;
- xiii) Offences against property;
- xiv) Criminal intimidation;
- xv) Attempts to commit any or all of the above mentioned offences against the victim(s);
- xvi) Threat to commit any or all of the above mentioned offences against the victim(s);
- xvii) Physical or psychological humiliation;
- xviii) All other offences following from the definition of “Ragging”.

Provided that the Dean/Principal shall forth with report the occurrence of the incident of ragging to the Vice-Chancellor. Provided further that the Constituent College shall also continue with its own enquiry and other measures without waiting for action on the part of the police/local authorities and such remedial action shall be initiated and completed immediately and in no case later than a period of seven days of the reported occurrence of the incident of ragging.

Administrative action in the event of ragging

1. The Dean/Principal shall punish a student found guilty of ragging after following the procedure and in the manner prescribed here in under:
  - a) The Anti-Ragging Committee of the University shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging establishment in the recommendations of the Anti-Ragging Squad.
  - b) The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, recommend, to those found guilty, one or more of the following punishments, namely;
    - i) Suspension from attending classes and academic privileges.
    - ii) Withholding/withdrawing scholarship/fellowship and other benefits.
    - iii) Debarring from appearing in any test/examination or other evaluation process.
    - iv) Withholding results.
    - v) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival etc.
    - vi) Suspension/expulsion from the hostel.
    - vii) Cancellation of admission.
    - viii) Rustication from the institution for period ranging from one to four semesters.
    - ix) Expulsion from the institution and consequent debarring from admission to any other institution for a specified period. Provided that where the persons committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.



- 2 The appeal shall lie with the Vice-Chancellor within fortnight from the date of issue of orders.
- 3 Where in the opinion of the appointing authority, a lapse is attributable to any member of the faculty or staff of the University, in the matter of reporting or taking prompt action to prevent an incident of ragging or who display an apathetic or insensitive attitude towards complaints of ragging, or who fail to take timely steps, whether required under these Rules or otherwise, to prevent an incident or incidents of ragging, then such authority shall initiate departmental disciplinary action in accordance with the prescribed procedure of the institution, against such member of the faculty or staff.

### **Suspension**

- 1 After having regard to the nature and gravity of the incident of ragging, the Dean of the college concerned/Principal of the constituent/affiliated private college with respect to the students is satisfied that it is necessary/desirable in the interest of the University to place under suspension, the student found involved in an act of indiscipline, he/she may place such student under suspension. Such suspension will not amount to any penalty having been imposed under the provisions under these Rules.
- 2 Such suspension will debar a student from availing any facility of the University.
